Dear friends of NPC,

Then, last month, I sat in a North Adams conference room hosting a convening of nonprofit leaders—people running food pantries, farms, yoga centers, small businesses, a state representative—all brainstorming solutions together. Despite the difficulty of this moment in time, they were leaning in, sharing ideas, building something bigger than any one of them could do alone. 

Doing More with More!

NPC'S LATEST COST-SAVING PROGRAMS FOR BERKSHIRE NONPROFITS!

The topic of nonprofits **sharing resources** comes up often as a way to mitigate challenges nonprofits face in funding their missions. If nonprofits can reduce their costs and increase their efficiency, then they can maximize their impact. But someone has to organize these initiatives across our very broad region of the Berkshires, home to one of the highest concentrations of nonprofits in the Commonwealth. NPC is grateful for the folks who <u>invest in our mission</u> and proud to be tackling solutions to high healthcare costs, scarcity of back office supports, staffing challenges and more.

COMMONWEALTH BENEFITS COLLABORATIVE

(A new health insurance plan for nonprofits)

We learned from a convening of Berkshire nonprofit leaders that rising healthcare costs are a top concern. After years of research, NPC has partnered with Acrisure to offer accessible health insurance plans that offer flexibility, more predictability, and easy administration. Acrisure is an independent financial technology and insurance company with local representation in Lee (formerly Toole Insurance Company). The initiative includes 8 competitively-priced health insurance plans through Cigna's national PPO network.

The timing couldn't be better as eligibility for subsidies (including Enhanced Premium Tax Credits which lowered monthly health insurance bills for many people) are set to expire on December 31 unless Congress extends them.

SHARED SERVICES PROGRAM

The Nonprofit Center of the Berkshires is partnering with Third Sector New England (TSNE) to give Berkshire nonprofits access to their Shared Services program for small to mid-sized organizations. With a focus on providing equity-centered front and back-office services such as administrative, financial and operations, TSNE offers accounting, bookkeeping, payroll and HR. Their services are open to all local nonprofits.

DISCOUNTS FOR NPC MEMBERS VIA AFFILIATE RELATIONSHIPS

- The More than Giving Company provides fractional staffing and virtual assistants to help with everything from strategic planning to fundraising consulting to administrative support.
- CORE 401K Program, run by the Treasurer's Office of the Commonwealth, provides nonprofits with 100 or fewer employees with an easy-to-administer **retirement savings plan**
- GrantStation offer NPC members access to their grant database for just \$139, a substantial saving off the regular price of \$699.
